PUBLIC HEARING ON THE BUDGET

Mr. Kennedy gave the 2019-2020 Budget Presentation and answered questions regarding budget. -Mrs. Ramirez asked what percent is the \$121 increase. Also, if the board is looking to purchase another building and another bus and hire another driver. With the change in curriculum will there be a gifted and talented program for middle schools.

-Mr. Kennedy responded that we are exploring all options and that the budget is a 2% increase and we are looking into a 29 passenger bus. The new bus will be for in district special education students route and the old bus will be for field trips and for sports trips. We are looking to hire a part time driver but we do have two drivers.

- -Mr. Severino asked what the 2% in tax points.
- -Mr. Evcil the 2% is \$300,545.00
- -Mr. Severino in the summary of revenue, there is a difference of \$500 for maintenance reserve with March Board Secretary report and asked if that is a typo.
- -Mr. Evcil responded it is the reserve interest which in the balance sheet line.
- -Mr. Severino asked what the intention for the \$438,277 from the fund balance.
- -Mr. Kennedy responded it is to replenish capital reserve.
- -Mr. Connors congratulated Superintendent Kennedy and the staff for the budget and for bringing back our out of district placement students back to town.
- -Mrs. Kohles stated that we no longer use a grant writing company, we are using Mr. Chiang with some of the administration and we are receiving grants and thanked everyone involved.
- -Mrs. Cabrera asked about window repairs at Bixby School, will there be space/room to put air conditioners in the windows. Also asked if aides will be receiving a salary increase too in the coming year. Also asked for a possibility to look into getting a grant that would include improving the athletic field. Also asked if there ever was an idea of adding a new preschool or a kindergarten building at new river front apartment buildings with the idea that there will be a student increase population.
- -Mr. Kennedy responded that we are looking into our next options. The first thing we needed to do was to get the windows repaired. We are looking to see how we can air condition all of our classrooms. Mr. Kennedy responded that no increase for now but we are looking at some possible situations with the aides moving forward for next year. In reference to the field, Mr. Kennedy responded that the big problem with the athletic field is where it is situated around water, flood zone. We do not know what we can do there because it floods.
- -Mr. Connors responded that the deal that was made with the developer was for community development money, in the ballpark of \$3,000,000 which was to be used for a rec center in town. Also, responded that from what he believes, the apartment buildings will not make a big dent in our school system, it will bring in some kids, but more professionals.

- -Announced the Teachers of the year, Mrs. Hunter in Bixby School, Mrs. Tarino in Steen School, and Mrs. Hrabovsky at Bogota High School.
- NJSLA testing will be next week.
